



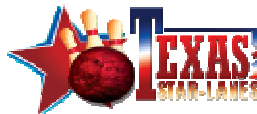

ENTRY FORM AND RULES ON BACK

TOURNAMENT RULES
(Failure to Read Is No Excuse)

HANDICAP DIVISION (Men & Women)

1. Eligibility - Eligibility - **All 2011 - 2012 TNBA members only, who are certified by USBC.**
2. Entries close March 2, 2012. Reserved entries must be accompanied by a certified check or money order. (NO PERSONAL CHECKS WILL BE ACCEPTED). No entry will be accepted where application is not fully completed. Entries will be accepted at the Bowling Center if spots are available. **THERE WILL BE NO REFUNDS FOR NO-SHOWS.**
3. Handicap - 100% of 220 for Men and Women.
4. Tournament Format: Three (3) games on a pair of lanes.
5. Averages: All averages must be highest 2010-2011 USBC certified league averages for 21 games or more. If no league average for 2010-2011, the 2011-2012 season highest average for 21 games or more at the time of bowling must be used. All others will bowl scratch. USBC Rule 319a-2 & 319a-3 applies (10 pin Rule) If current average is ten or more pins higher than last season's average, current average must be used. **NO SUMMER** averages will be used.
6. Re-Rating: USBC Rule 319c, 319d & 319e will apply to all entrants.
7. Current PBA/PWBA or Senior PBA, regardless of classification will not be permitted to bowl in this tournament. Past PBA/PWBA champions, regardless of classification, may be permitted if their championship was not within the last ten (10) years. Former PBA/PWBA members who have not held a card for the past two (2) years are eligible to bowl in this tournament.
8. Prize fund will be paid 100%. Prize ratio will be at least one (1) prize for every ten (10) entries.
9. Membership Cards - TNBA cards at \$25.00 & USBC cards at \$21.00 may be purchased at the Tournament site for this event.
10. Premature termination of the tournament brought about by war, national emergency or emergency causes relating from; fires, strikes, lockouts, labor difficulties or other reasons beyond the control of the Bill Rhodman Classic, shall cause the foregoing prize schedules to be prorated in accordance with the number of entrants who have bowled.
11. All rules not stated above will be governed by TNBA and USBC rules.
12. Anyone employed by Texas Star Lanes from January 1, 2012 until the end of the tournament is not eligible to participate.
13. The Tournament Director will make all decisions and reserves the right to refuse or reject any entry.
